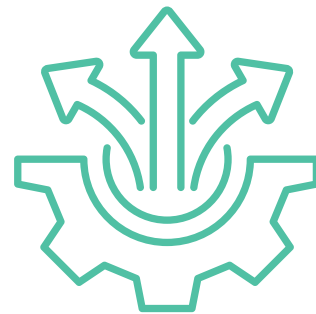

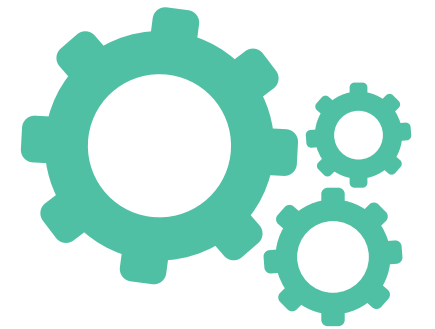

A Bermuda Exempted Company can typically be incorporated within 5–10 business days and requires a minimum of one director and one shareholder, who may be individuals or corporate entities of any nationality.

Exempted Companies are designed for international business and benefit from Bermuda's tax-neutral regime, with no corporate income, capital gains, or withholding taxes. Shareholder information is not publicly available, while every company must maintain a registered office in Bermuda and appoint a Bermuda-resident representative, director, or secretary to satisfy local presence requirements.
